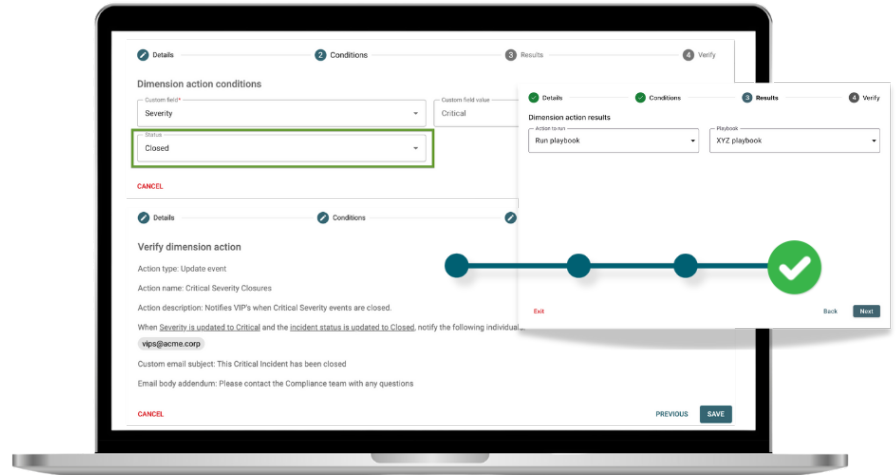

Automatically running a Playbook designed for a common enterprise scenario, such as a lost laptop, or sensitive documents left in a public office space, ensures that lower-priority incidents are resolved quickly and consistently while reducing the manual processes required to address common, low-risk events.

Automatically set incident group(s) based on a predetermined custom field value.
